Outdoor Lighting Bylaw Promotes Dark Skies

Strobe Lights Prohibited

A flood of complaints about bright white strobe lights used to mark the open water created by bubblers in the winter prompted the township to develop a bylaw to regulate outdoor lighting. These strobe lights appeared on the lake recently after property owners were alerted of their responsibility to adequately warn of open water created by their bubblers. Although installed with good intentions, strobe lights can be very disturbing to neighbouring properties, throwing a penetrating white flashing light directly outward, causing what the bylaw refers to as "light trespass" all winter long.

Council decided that this specific form of light pollution issue presented an excellent opportunity to develop a formal dark sky bylaw. The Lake of Bays Association has long advocated for a dark sky bylaw to encourage the installation of low wattage, energy efficient lighting that is oriented downwards to minimize glare to prevent light trespass, reduce disruption for wildlife and to preserve the night sky for all to enjoy.

The Dark Sky Bylaw that passed unanimously on October 8 is quite comprehensive and can be accessed on the township website (www.lakeofbays.on.ca).

President's Message

This year several interesting issues came to the attention of LOBA, including resort planning, new cell tower proposals and the possibility of ATV use on our public roads. Public opinion on cell towers and ATVs has been widely split. Lake of Bays Township councillors narrowly approved the revised Baysville cell tower design and site proposed by Rogers. They heard arguments and proposals related to ATVs and directed staff to prepare a report and draft a by-law for the October council meeting, the outcome of which is reported elsewhere in Current Connection. LOBA members were on both sides of each issue, and we define our role as investigative, providing information to our members. Because the com-



munity, meaning all of us, is divided on these issues, it is important for everyone with an opinion to express it to our elected representatives. They are charged with weighing the information and public sentiment and ultimately drafting legislation.

I would like to take this opportunity to welcome our 2013–14 board of directors, particularly Pat Birnie, Bob Breithaupt and Caroline Konarzewski who are new to the board this year. Contact information for all board members is listed here in Current Connection and on our website www.loba.ca. I would like to thank retiring Board members Barry Johnson and Gundy Upans and in particular, Mary Neal, who served on the board for 15 years, including three as presi-

dent, providing sound and empathetic leadership. Our organization thrives because we have a solid team of dedicated, skilled and passionate volunteers. I salute each and every one of them for their hard work.

Three-quarters of the residents around the lake are LOBA members, giving the Association a credible voice at all levels of government. Please allow us to continue to look after your interests by completing your membership renewal now. We have made it easier than ever. Renew by mail or securely online, by cheque or credit card.

Outdoor Lighting Bylaw Promotes Dark Skies

For residential property owners, the regulations apply to lighting on buildings, structures, canopies, overhangs, docks and boathouses, recreational areas, parking lots and landscape lighting. All new outdoor lighting installations or replacements must be “full cut off” lighting that directs light downward. The bylaw includes illustrated examples of full cut off fixtures. Even if your outdoor lights do not need replacement, we encourage all property owners to consider upgrading their outdoor lighting to be dark sky friendly.

With respect to lights used to warn people travelling on ice of the danger of open water created by bubblers, the use of strobe

lights is prohibited. The Dark Sky Bylaw is effective immediately, so if you have a strobe light on your dock or boathouse, it must be replaced with a more sensitive lighting option this winter. The snowmobile community has requested that bubbler warning lights NOT BE RED because such warning lights can be mistaken for the rear running lights of snowmobiles. An amber warning light has been suggested as a more appropriate choice for bubbler lights because it indicates “warning” and is dark sky friendly. YOU ASKED...

Who do I call if I accidentally injure or kill a deer on the road with my car?

This is a situation no one wants to be in; collisions with wildlife on the road are not only frequently fatal for the animal, but are also extremely dangerous and can cause extensive damage. But accidents do happen and if you have injured or killed a large animal, such as a deer or moose, and are unable to move it off the road, call the OPP (* 677 on your cell phone). The OPP will come and shoot an injured animal and move it to the side of the road before contacting the Ministry of Transportation Ontario (MTO) to come and remove it. Even if the animal is dead and you are able to move it safely to the side of the road, you should still call the OPP and they will arrange for the carcass to be picked up by the MTO. In order to avoid a collision in the first place, some motorists swear by the Sonic Deer Whistle or similar devices which are mounted on your cars to warn wildlife away. Scientific studies, however, offer mixed findings about the effectiveness of those devices. It is always best to be extra vigilant when driving in cottage country. Don't feed the deer at any time as this encourages them to hang around near the source of food, which is often near the road.

Re-greening the Township Office Site!

There has been casual conversation over the past several years about re-greening the Township Office site in Dwight. Lake of Bays Township citizens, elected politicians and staff agreed that the flat, grassed space surrounding the Township offices does not reflect either the Township's environmental values or its position as a rural municipality on the Canadian Shield. There had been hopes that G8 infrastructure grants would result in a general improvement to the buildings and site but no funds were allocated. So, discussions about what could and should be done to the space were initiated at the end of January by planning staff, the Lake of Bays Association and HOLD (Hillside, Oxtongue Lake, Dwight Community Group). Township Planner Stefan Szczerbak wisely brought LOBA and HOLD together given the community group's intention to fundraise for and erect a township sign, complete with a scrolling LED calendar of events. It was

agreed that the sign project needed to be part of the re-greening plan because the site's proximity to Highway 60 means that both Township and Ministry of Transportation (MTO) approval is required before any work can proceed on the property. Our informal group met with MTO on-site in the spring and everyone's goals were discussed within the context of the Ministry's requirements. HOLD wanted a visible, rustic, sign to convey information and the Association wanted to naturalize certain selected areas on the site. With this direction, HOLD finalized a design and cost profile for the sign, while we hired BarK Nursery to prepare a concept plan for the re-greening that incorporated the sign. The concept was presented to Council in May and unanimously approved. The project is set to proceed subject to final approval of a site plan from MTO, which we are hoping to receive soon—we need it soon if there is to be any fall planting done.

The project will be very much a collaborative affair, despite the fact that it began life as two separate projects—HOLD's sign and LOBA's re-greening. LOBA has given \$2,000 towards the sign, recognizing that quality signage is of value to the entire community and volunteers from Dwight community will be helping with the re-greening. As usual, the Dwight Garden Centre will be helping us with the costs and implementation of the project and we will be asking the local community to donate their time to digging the beds and planting. The project will feature plantings grouped in pockets to soften the sign and the building and also to screen the generator.

We are hoping to do some fall planting but if approvals take longer than expected, watch for activity in the spring of 2014!

ATV Bylaw Passes with Limitations

Two-Year Trial Begins in 2014

On October 8, Lake of Bays Township Council passed a bylaw allowing All-Terrain Vehicles (ATVs) limited access to specific Township roads for a two-year trial period. The roads approved for ATV use, and listed below, were proposed by the Baysville ATV club as routes to provide access to ATV trails on Crown lands south of Highway 117 and to the villages of Dorset and Baysville. Road access for ATVs is limited to May 1 until December 31 and only from sunrise to sunset. The bylaw also imposes a speed limit of 20 km/h in zones of 50 km/h or less, and a maximum of 50 km/h where the speed limit exceeds 50 km/h. In all other respects, ATV users are subject to the Ontario Highway Traffic Act: drivers must have a valid driver's license as well as vehicle insurance and must be wearing a helmet. Passengers are not permitted. The definition of what is considered to be an ATV is set out in the provincial Off-Road Vehicles Act.

At the October meeting, Mayor Bob Young noted that this issue has generated more input from residents than any other issue in the three years of this council's term. The three public meetings held in July were well attended and written and verbal input was received by council at their August, September and October meetings. Mayor Young estimated that 60 percent of written correspondence was opposed to permitting ATV access to township roads, and verbal presentations to council were evenly split in support and opposition. Eventually, the original proposal by the Baysville ATV Club to permit ATVs on all township roads year-round was amended to a limited number of roads in three seasons with time of day restrictions, mainly in response to expressed concern from residents. The amended bylaw was passed with a vote of five in favour and two opposed.

LOBA's membership is also divided on this issue. We did our best to make sure our members were aware of the proposal and that you knew how to provide input to council. Additionally, our Board of Directors felt a responsibility to press for a decision that ensured that the safety, peace and quiet and

environment of Lake of Bays are protected for the benefit of the majority of residents. On August 1 the Lake of Bays Association submitted a letter (read it on www.loba.ca) asking that our concerns about safety, liability, environmental degradation, road maintenance, Official Plan conformity, monitoring/regulation, economic benefits, and financial impacts be considered prior to passing a bylaw. While the staff report considered at the October council meeting did address these concerns, LOBA was disappointed that, rather than obtaining an opinion from legal counsel on the extent of increased liability assumed by the township with this bylaw, the report relied only information from the township's insurance provider. Given the growing number of ATV accidents and related lawsuits in the last few years, we felt that this added risk warranted a legal opinion. The staff report is available on the township website (www.lakeofbays.on.ca) under the October 8 council meeting agenda.

The trial period for the bylaw begins on May 1, 2014 and ends on January 1, 2016, at which time staff will report on complaints tracked by the bylaw department over the duration of the trial period. Mayor Young has expressed an interest in conducting an interim review at the end of one year. New Community Park for Dorset

The Ontario Trillium Foundation awarded a \$62,500 grant to the Dorset Community Partnership Fund to support the development of a community park in the old school yard on Main Street. A pavilion, accessible washrooms, fencing and goal posts will be installed next summer to enhance opportunities for sports, recreation, and arts and culture in the community. A special fundraising drive will direct all proceeds to the Community Park. To date about half of the fundraising goal has been met.
